O R D E R

Pursuant to our earlier direction, the State of U.P. has filed fourth, fifth and sixth reports in the form of an affidavit highlighting the steps taken by it. In addition to the same, the State has also filed a chart containing the existing camps and persons residing there.

On behalf of the Union of India, learned Attorney General has submitted a report containing various communications from the Central and the State Government in the form of an affidavit in Court. The same is taken on record.

W.P.(CrI.)No. 181 of 2013 is taken on Board.

Exemption from filing O.T. in W.P (CrI.)No. 170 of 2013 is allowed.

Issue notice in the W.P.(CrI.)No. 181 of 2013 filed by ANHAD and W.P.(CrI.)No. 170 of 2013 filed by Citizens for Justice & Peace & Ors.

After hearing all the counsel at the request of Mr. Rajeev Dhawan, learned senior counsel, appearing for the State of U.P., we

intend to give sufficient time to respond the fresh writ petitions, the writ petitions as well as various applications in which we have issued notice on the last hearing date. We direct the State to file a detailed response in regard to all the matters mentioning the steps taken up to 17th November, 2013 and the future course of action to maintain peace and communal harmony positively by 18th November, 2013.
